**I. Contracting Parties:**

Taking into consideration the Decision no. 299/19.02.2021 related to the amount of the annual tuition fess, the amount for the installments and deadlines for payment of the tuition fees,

The Parties agreed to sign this Addendum, with the following content:

**Art. 1. Point 5.5. from Chapter IV of the Study Framework Agreement is modified with the following content:**

5.5. The student has to pay the established tuition fees according to the Regulations of the University of Medicine and Pharmacy until the end of the academic year in 3 parts: 1<sup>st</sup> part until **October 15<sup>th</sup>, 2021**, 2nd part until **January 21<sup>st</sup> 2022** and the 3<sup>rd</sup> and the last part until **June 3<sup>rd</sup> 2022**. For the extra-ordinary session for increasing marks, credited exams and failed exams, the students have to pay the fee of this period, according to the decisions adopted by the university and published on the university website, according to the structure of the academic year.

The fee for this academic year (2021 - 2022) is 5000 Euro, and must be paid in three instalments:

- I<sup>st</sup> installment - 1500 euro
- II<sup>nd</sup> installment - 1500 euro
- III<sup>rd</sup> installment - 2000 euro.

The fee for final complementary year is 1500 Euro and must be paid in until **October 15<sup>th</sup> 2021**.

**Art. 2. Annex 1, entitled "Consent to processing of personal data" is part of the study contract. Other provisions from the study contract are unchanged.**
